

EEG & EnEV. Klimagerechte Zwangsmaßnahmen des Staates

In der langen Reihe der mit Angst begründeten politischen Entscheidungen der vergangenen Jahre steht den Bürgern bald mit der Novellierung des Erneuerbare-Energien-Wärmegesetzes ein neues Prachtexemplar der Klimaangst-begründeten Zwangs- und Schröpfungsmaßnahmen ins Haus. Das ist wörtlich zu nehmen, denn nun kommt zum bislang größten Abzocke-Instrument EEG-Umlage der Zwang für alle Hauseigentümer, endlich Anlagen der sogenannten Erneuerbaren Energien in ihr Haus einzubauen. Daß es teuer wird, ist den Planern im BMU klar. Deshalb soll zum Zwang auch die Gnade kommen: Etwaige Härtefälle könnten von dieser Pflicht ausgenommen werden.

Als die Ideologen die Gesetzesmaschinerie eroberten

Es wird vielen als Rätsel erscheinen, daß ausgerechnet die derzeitige Regierung aus CDU/CSU und FDP eine Politik betreibt, die man nur von einer von den GRÜNEN geführten Regierung erwarten könnte. Am deutlichsten wird das bei der Energiepolitik, die heute nur noch eine Untermenge einer Klima-Angstpolitik ist. Für diese äußerst merkwürdige Situation gibt es historische Gründe:

Die GRÜNEN bekamen 1998 als Juniorpartner der SPD mit der Zuständigkeit für das Bundesumweltministerium BMU die entscheidenden politischen Werkzeuge zur Umsetzung ihrer Politik in Form von staatlichen Gesetzen und Verordnungen in die Hände.

Nach einer relativ kurzen Zeitspanne waren die meisten Fachbeamten des Ministeriums kaltgestellt, versetzt oder hinausgemobbt und durch ideologisch gefestigte Neuzugänge aus den verschiedenen Öko-Instituten ersetzt worden – und seither versorgen diese Leute ihre Minister mit „Sprechzetteln“, Leitungsvorlagen, Pressemeldungen und Gesetzesentwürfen.

Daran hat sich auch unter den späteren Ministern Gabriel, Röttgen und Altmeier, die beiden letzteren immerhin von der CDU, absolut nichts geändert. Sie hätten die fachliche Kompetenz ihres Hauses durch wesentliche personelle Veränderungen wiederherstellen müssen – und sie taten nichts dergleichen. Die Bilanz eines völligen Versagens. Die Konsequenz dieses Versagens ist die vollständige Steuerung der selbst fachlich unbedarften BMU-Minister durch die grüne Beamtenschar. Es ist daher so, als ob immer noch Jürgen Trittin Minister wäre.

Geändert hat sich außerdem der Bereich der faktischen Zuständigkeit dieses grünen Ministeriums: Der für die Energiepolitik zuständige Wirtschaftsminister Rösler ließ sich anscheinend widerstandslos jegliche Initiative aus den Händen nehmen und heute ist das BMU das tatsächlich

entscheidende Energieministerium – mit dem Wirtschaftsministerium als nur noch leise quengelndem Anhang.

Das alles geschah und geschieht allerdings mit Zustimmung und Duldung durch die Kanzlerin, die diesem Treiben leicht ein Ende setzen könnte – wenn sie es nicht genau so wollte.

Die Energiepolitik wird seither von den GRÜNEN bestimmt, und das wird sehr erfolgreich in enger Zusammenarbeit mit den ebenfalls sehr von Grünen besetzten Zeitungs- und TV-Redaktionen durchgeführt, die Druck auf das Parlament und die Regierung ausüben.

Deshalb besetzt allein das BMU auch das Thema Wärmeversorgung, bei dem die nächste Welle von Zwangsmaßnahmen vorbereitet wird und von dem weiter unten die Rede sein soll.

Politik mit der Angst

In der nun von Ideologen besetzten Umweltpolitik und in der von ihr vereinnahmten Energiepolitik wird seit Jahren das Prinzip der Angstverbreitung zusammen mit den dazu gehörenden staatlichen Regulierungs- und Zwangsmaßnahmen, die den Übeln abhelfen sollen, erfolgreich angewendet. Dazu eine Reihe von Beispielen.

Mit Umweltschutz begründete Maßnahmen:

Das Duale System der Mülltrennung, die Abgasmessung von Heizungsanlagen, die Abgasuntersuchung von PKW, die
